A Special Meeting of the Eagle Valley Owner's Association is being called by your Board of Directors on Monday, February 27, 2012, at 7:00 p.m. at Eagle Valley Golf Course Clubhouse, 2600 Double Eagle Lane, Woodbury, MN 55129. Registration will begin at 6:15 p.m.

The specific purpose of this meeting is to hold an election to the following Board positions:

- 1. The two-year (2) Board of Directors term currently held by Jeff Heinrich.
- 2. The one-year (1) Board of Directors term currently held by Bill Thom.

No other Association business will be conducted at this meeting.

Why do we need a Special Election?

In the middle of November two of the three Board Members, Tom Laska & Beejay Zager, resigned their positions. The Association Bylaws require a quorum of the Board (at least two) to conduct business. Following the advice of the Association's lawyer the remaining Board Member, Chuck Eckberg, determined that the best course of action to fill the open positions was to hold elections at the December 5, 2011 Annual Meeting, in order to restore the board to full membership at the earliest possible time. At this meeting, homeowner John Showalter, made an objection to holding the elections for the two open positions on the grounds that there was not 15 days notice and that the Proxy Statements did not clearly state that they covered the additional positions being voted on. The decision was made at the meeting to follow the advice of counsel, and the elections proceeded. Jeff Heinrich and Bill Thom were elected, by acclamation, to fill the two-year and one-year terms, respectively.

On December 16, 2011 the Association received a written Notice of Objection and Call for a Special Election from homeowner Tom Laska, citing the same issues raised by Mr. Showalter at the annual meeting. Mr. Laska indicated that if the board didn't hold a new election he was contemplating legal action, perhaps involving other homeowners.

In January, the newly elected Board consulted again with the Association's legal counsel on how to move forward. While counsel felt that the December elections would ultimately be upheld, the Board of Directors decided that, based on residents concerns over the size of previous Association legal bills, we would agree to call for a Special Election.

On February 1, 2012 the Board of Directors officially called for a Special Meeting & Election to be held on February 27, 2012 under Article IV, Section 3 of the Association Bylaws which states:

Article IV, Section 3. Special Meetings. Special Meetings of the Members may be called at any time by the President or the Board of Directors, or upon written request of the Members who are entitled to vote one-fourth (1/4) of all the votes of the Membership. The notice of any special meeting shall state the time and place of such meeting and the complete agenda thereof. No business shall be transacted at a special meeting except as stated in the notice.

No business can be transacted legally at a Special Meeting without a quorum of 10% of the members present, either in person or by proxy. The Board of Directors sincerely hopes that all members will be able to attend in person. However, if you cannot attend this important meeting, please complete the enclosed proxy and deliver it to the Secretary of Eagle Valley Owner's Association, in care of Durand & Associates Property Management, Inc., AMO[®], BridgePoint Business Park, 152 Hardman Avenue South, South Saint Paul, MN 55075, or to another owner member or Board Member you wish to designate to vote your proxy, and who will be attending the Special Meeting. Should any other member of Eagle Valley Owner's Association wish to run for either of these Board of Directors positions, they may do so. A résumé has been included for this purpose. Nominations for these two (2) positions will also be taken up to, and following the meeting agenda on the 27th of February, 2012.

All Eagle Valley Owner's Association members are urged to attend this important meeting. Voting registration will begin at 6:15 p.m. to ensure the establishment of a quorum at the 7:00 p.m. start time.
